

General terms and conditions

Consent and liability waiver notice | HETibiza

This participation notice and liability disclaimer informs all participants about the nature of the activities organized by HETibiza and the associated risks and responsibilities. By booking and/or participating in any excursion organized by HETibiza, participants are deemed to have read, understood and accepted the contents of this notice. Participation constitutes acceptance of these terms without the need for a separate signature.

1. Applicability

This participation notice and liability disclaimer applies to all persons who book, attend, or participate in any activity organized by HETibiza, including but not limited to bike tours, e-bike tours, hiking tours, walking tours, bus tours, boat excursions, and any other excursions or activities offered by HETibiza.

These terms apply from the moment a booking is made or a participant joins an activity, regardless of whether a separate waiver has been signed. By booking and/or participating, participants are deemed to have accepted the contents of this notice.

2. Participation

By participating in an excursion organized by HETibiza (including but not limited to bike tours, hiking tours, bus tours and other activities), participants acknowledge that they participate voluntarily and accept the terms of this notice.

3. Health and physical condition

I declare that:

- I am in good physical and mental health
- I am physically capable of participating in the activity
- I have informed the organizer of any medical conditions or injuries in advance
- I am responsible for carrying and using my own medication

The organizer is not responsible for any health issues that occur during or after participation, unless caused by proven negligence.

4. Risks and personal responsibility

I understand that participation involves risks, including but not limited to:

- Physical injury or accidents
- Traffic-related incidents
- Slips, trips, or falls
- Weather conditions (heat, sun, rain)
- Unforeseen circumstances

I fully accept these risks and participate at my own responsibility.

5. Liability

- The organizer has business liability insurance
- This insurance only covers damages in cases of proven negligence

I declare that:

- The organizer is not liable for injury, damage, or loss unless caused by gross negligence or intent by myself
- I am responsible for my own safety and behavior
- I will follow all instructions given by the guide

6. Personal insurance

I am responsible for having valid travel and/or accident insurance that covers participation in these activities.

7. Damage and personal belongings

- I am responsible for any damage I cause to equipment or third parties
- The organizer is not liable for loss, theft, or damage to personal belongings

8. Alcohol and substance use

The organizer reserves the right to refuse or terminate participation in case of excessive alcohol consumption or use of drugs.
